The soft acids in the formula gently etch the surface, revealing a brighter and more vibrant grout color.

WHERE TO USE

- Removes dried cement, grout haze and mortar residue from tile, concrete and masonry.
- Removes hard water deposits and efflorescence.
- Safe for use on most cement-based colored grouts, tile, clay pavers, concrete and masonry.

Before using any cleaner, do a sample test in a small inconspicuous area to verify acceptable results.

LIMITATIONS

- Do not use this product for your everyday deaning. Excessive and over-usage can result in surface damage.
- Recommended usage is a maximum of 1-2 times per year.
- DO NOT USE ON POLISHED MARBLE OR POLISHED STONES AND AVOID CONTACT WITH METALS.

PRO CLEAN

APPLICATION

- 1 Apply a slightly damp layer of water over the grout, just enough to wet the surface for deaning.
- 2 Immediately apply the cleaner, spraying small areas at a time.
- 3 Allow the cleaner to work into the surface for 2 or 3 minutes and then with a brush or sponge, scrub the surface areas to remove the hardened dirt and other contaminates.
- 4 Immediately rinse clean with water.
- 5 It is recommended to use the Pro Clean 10 days after the grout installation to remove any remaining grout residue.
